

Garage Giveaway for the Golden Generation

(Garage Living Franchise Systems USA Inc. and Garage Living Franchise Systems Inc.)

TERMS AND CONDITIONS

Eligibility

To enter, submit an impact statement that includes a brief story, a photo or video of the garage, and an explanation of how a renovation would improve daily life. This impact statement can be submitted by providing a picture or video of your garage, with a written explanation included. The written component must be no longer than 250 words, and if you choose to submit a video, it must be no longer than 3 minutes. Participants may submit on behalf of themselves or another individual, however the candidate entered must be at least 55 years of age or older, own a home, and be a legal resident of the U.S. or Canada.

Eligibility is void where law prohibits or restricts participation. To ensure fairness, family members of the same household cannot make multiple submissions. Garage Living Franchise Systems USA Inc. and Garage Living Franchise Systems Inc. employees and their immediate families; contractors; representatives of affiliates; subsidiaries; promotion; fulfillment agencies; suppliers and vendors are NOT ELIGIBLE to nominate or receive a nomination. The Sponsor reserves the right to verify the eligibility of each nomination. Participation constitutes the entrant's full and unconditional agreement to these terms and conditions, which are final and binding in all matters related to the giveaway. When making a submission, you confirm that all parties involved (either you or both you and the submitted candidate) have agreed to participate and share their photo (if included). The winner may choose to decline the garage renovation if they wish.

How to Enter

If you or an older adult you know has lost the value of the garage, due to it becoming a cluttered, unsafe or inaccessible space, nominate someone who deserves a better garage. Tell us their story and show us the space. *Entries must include either a photo or a video (max 3 minutes) of the garage, along with a written explanation (max 250 words) describing how a transformation would help.* To participate, entrants must be at least 55 years of age or older. You may only submit yourself once, and there is no limit to how many submissions you can make on another's behalf.

To make a submission, please visit the website www.garageliving.com/GID2025 and complete the entry form with the required information. All entries must adhere to the terms of this giveaway. Any fraudulent methods or attempts to circumvent the rules may invalidate your nomination. Including a photo of the participant with the entry form is optional and will not influence the outcome of the giveaway.

Entry Period

The entry period for the Garage Giveaway for the Golden Generation begins May 1, 2025, at midnight EST and ends June 16, 2025, at noon EST. Entries submitted before or after this period will not be eligible.

Agreement to Official Rules

By participating in this giveaway, entrants agree to abide by Garage Living's official rules and decisions. These rules and decisions are final and binding in all matters related to the giveaway. By entering, participants agree to accept the decisions of Garage Living as final. Any attempt to undermine the legitimate operation of the giveaway may be a violation of criminal and civil laws. In the case of such an attempt, the Sponsor reserves the right to seek damages to the fullest extent permitted by law. Garage Living reserves the right, at its sole discretion, to refuse, withdraw or disqualify any entry at any time without notice. Giveaway Details and Conditions

Garage Living will keep the entrant's street address strictly confidential.

Odds of Winning

The odds of winning the Garage Giveaway for the Golden Generation are determined by the number of eligible entries. A panel of judges will evaluate each entry's merit and the participant's grade of need for a garage renovation. As such, the more entries the Sponsor receives, the lower the odds of winning. The Sponsor encourages participants to provide detailed and compelling stories about their current garage situation to increase their chance of winning.

Selection and Notification of Winner

Judges will select the winner of Garage Living's Garage Giveaway for the Golden Generation based on the degree of need and volume of challenges the older adult is facing with their current garage arrangement. Garage Living will notify the winner on June 18, 2025. Upon notification, the winner will have three days to claim their prize. If the winner fails to connect with Garage Living in this timeframe, they forfeit the prize, and judges will select a new winner. Garage Living is not liable if the nominee fails to receive notifications due to their entry containing incorrect contact information or if their email security settings send the giveaway notification to a spam or junk folder.
